Now 15 years old, Jaysa continues to galvanize audiences with a courage and wisdom that belie her years.

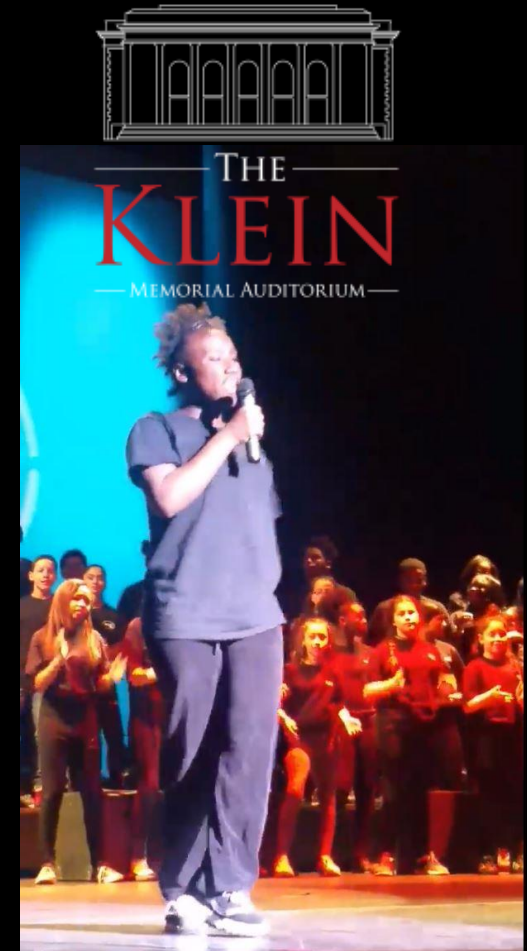

- Winner of Best Of Best Award At The "My Hero International Film Festival"



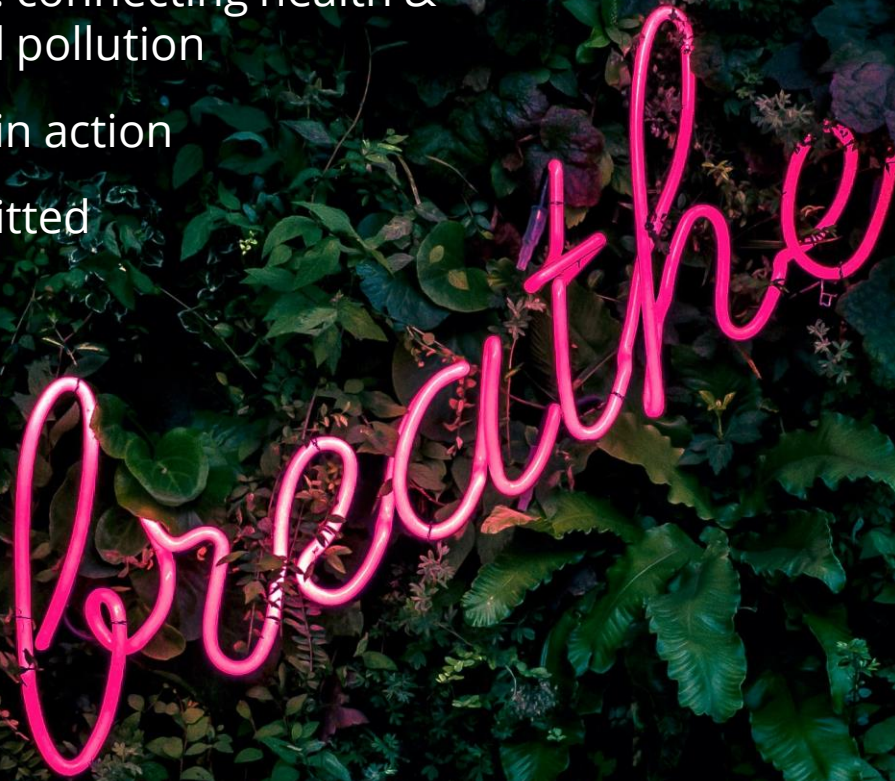




RACISM & ENVIRONMENTAL JUSTICE

- ***"Our racial inequality crisis is intertwined with our climate crisis. If we don't work on both, we will succeed at neither."*** *Dr. Ayana Elizabeth*

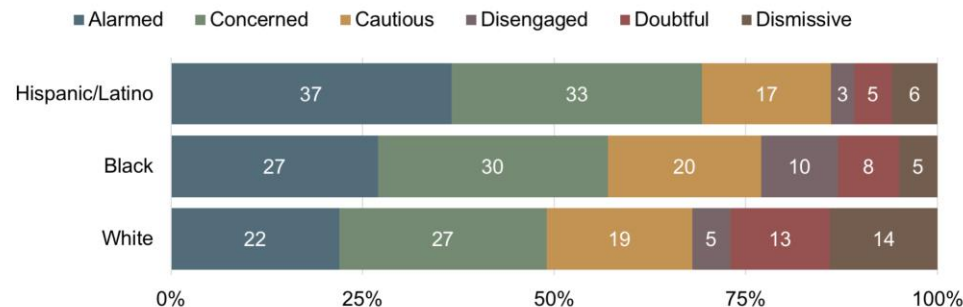
- According to the NAACP report, 78 percent of African Americans live within 30 miles of a coal-fired power plant
- 71 percent of African Americans live in counties that violate federal air pollution standards, as compared to 58 percent of the white population
- Asthma affects African Americans at a 36 percent higher rate of incidence than white
- According to Yale Environment 360, an African American child is three times more likely to go to the emergency room for an asthma attack than a white child and die of asthma at twice the rate of whites

MY COMMUNITY — BRIDGEPORT, CT

- 
- Jaysa Mellers
17 years old
- Largest & poorest city in state
 - One of CT's few ethnic communities
 - Fairfield County has some of the worst air pollution in the Northeast
 - 20.3% White / 35% Black / 40% Hispanic & Latino (crossover)
 - Medium household income per household is \$45K
 - 21.4% of people live below the poverty level
 - Lack of comprehensive, affordable health care

CHANGE THE NARRATIVE – YOUNG PEOPLE OF COLOR ARE MOST CONCERNED & WILLING TO TAKE ACTION ON CLIMATE CHANGE

Hispanic/Latino and Black Americans are more likely to be Alarmed or Concerned about global warming than are Whites

Yale Program on Climate Change Communication's recent research shows that:

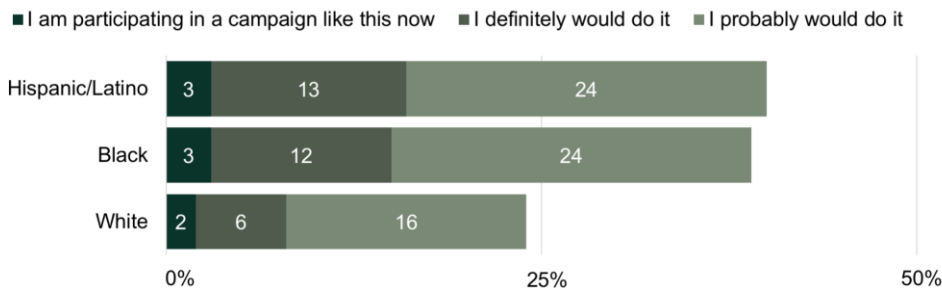
People of color in the U.S., including Hispanics/Latinos, African Americans, and other non-White racial/ethnic groups, are more concerned than Whites about climate change.

They also report greater willingness to join a campaign to convince elected officials to take action.

Climate change disproportionately affects members of disadvantaged communities and groups who face socioeconomic inequalities, including many people of color.

As the United States becomes more racially and ethnically diverse, promoting public engagement with climate change across diverse audiences is becoming increasingly important.

- I started speaking at environmental rallies and found my calling. **Words show my passion & outrage**; Call people's attention to environmental racism through my story; Leaders listened; **The plant was shut down!!!**
- Different ways to commit to activism; **Find your love language!**
- **The power of young voices:** to tell the truth, speak to the heart, wake people up;
- **The power of success stories, especially of diverse young role models**
- **Young Voices for the Planet model:** Teach with hope & action vs. doom & gloom

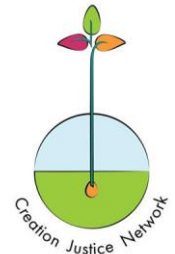

Words Have Power', Young Voices for the Planet's award-winning film reached audiences across the country and is **being used to catalyze community conversations and youth-led climate action in other environmental justice communities, particularly in Western PA** where the fracking and petrochemical industries dominate and people's health is suffering from air and water pollution.

Communities of color have been routinely disenfranchised and oppressed by the political system and consequently, young people of color are particularly frustrated.

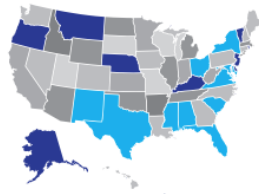
We need a **commitment to Participatory Democracy through civic education — taught comprehensively and equitably across schools, so more young know how they can make a difference!**

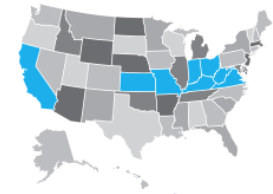

THE CITIZEN

Describes a vision of the good society, is trusted by others, able and willing to defend the movement against criticism from those in power and supports a non-violent approach.

You are: Grounded, diplomatic, articulate, business casual optional



THE REBEL

Draws attention to issues on society's agenda, represents society's moral vanguard in the gap between what is and what should be, and leads in the 'take off' phase of a social movement when 'trigger events' gains mass attention for the movement.

You are: Courageous, risk taker, brave, probably has a Ché Guevara t-shirt



THE Social Change Agent

Nurtures agreement in the community, continuously learns through dialogue, promotes alternatives and educates, convinces and involves majority of ordinary citizens and whole society in change.

You are: Charismatic, strategic, good communicator, has a tie for each occasion



THE REFORMER

Promotes major reforms in negotiations with 'the system' to get movement goals, values, alternatives adopted into official laws, policies and conventional wisdom through lobbying, lawsuits, referenda, official rallies, corporations, local authorities, candidates etc.

You are: Headstrong, resourceful, with multiple suits

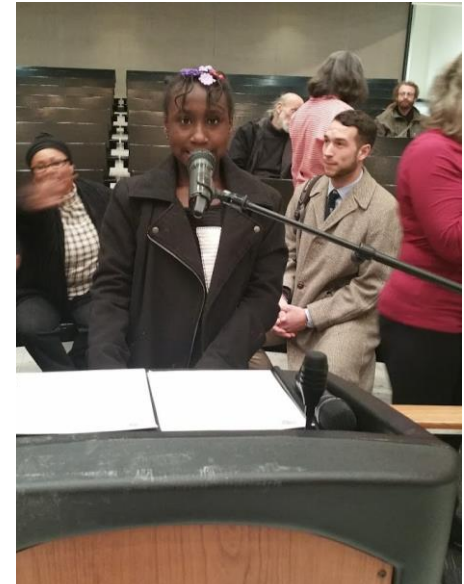
ACTION PLAN – FIND YOUR PASSION, PEOPLE & POWER
